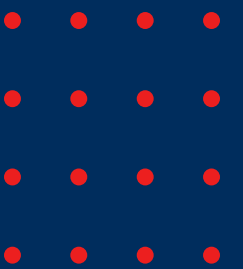
● ● ● Why BPC?
